I also give authority to the Youth Camp security/patrol staff to inspect said minor's room and belongings while on campus for the safety and protection of all Youth Camp participants if unusual circumstances make such an inspection necessary.

ETC Youth Camp Rules 2012

1. Students are not allowed off campus.

Students must remain ON CAMPUS from the moment of registration on Sunday until check-out on Thursday.

2. Students are not allowed to ride in or on any vehicle.

Everyone will walk while attending Youth Camp. There will be no movement of cars, buses, vans, motorcycles, skateboards, roller skates, or roller blades on the campus. All vehicles must be parked in the parking lots from the time of registration on Sunday until load up on Thursday.

3. Students must attend ALL scheduled activities, including color school times, family group times, recreation, meals, special events, and worship services.

If your assigned color school or family group is involved in a scheduled activity, whether in the worship center, under a pavilion, or on the athletic field, you must be with them. There are no exceptions to this, unless you are injured or sick and are at the nurse's office.

4. Students must wear nametags at all times.

Nametags are required to eat in the cafeteria. Replacement nametags can be obtained from the Camp Director for \$1.

5. Students who are ill or injured must be in the Youth Camp nurse's office.

In the event of illness or injury, students will not be permitted to remain in their dorm rooms. Students who are injured or ill will be required to rest in the nurse's office until they are able to return to the regularly scheduled activity or session of their color school or family group.

6. Students are not allowed to share any medication with any other student.

ALL medications each student uses or brings with them to Youth Camp are to be listed on their registration forms and given to the

Youth Camp nurse. ALL medications will be dispensed by the Youth Camp nurse.

7. Students MUST be in the dorm at the time announced each evening.

Lights out at 11:30 PM. ALL students are required to be in their assigned dorms at the announced time. Your curfew is for your safety and your mental and physical well-being. The daily schedule is very demanding.

8. Drugs, alcohol, any form of tobacco, firearms, knives, or fireworks are NOT allowed.

ALSO, DO NOT BRING iPods, PSP's or any other type of electronic games or equipment, cellular phones, or computers. Sponsors may bring equipment they need for their individual church's share time.

9. Students must dress appropriately.

Casual clothing is acceptable during all activities at Youth Camp, with the understanding that all clothing should reflect modesty and discretion. No short shorts or two piece swimming suits, no sheer clothing, no low-cut dress necklines or deep armholes in dresses or shirts. Tennis shoes are strongly recommended, especially for daytime activities. Cover-ups and shoes must be worn to and from the pool.

10. Refrain from Public Displays of Affection (PDA) with girlfriends or boyfriends.

11. Under NO circumstances are girls to be in boys' rooms or boys to be in girls' rooms. NO EXCEPTIONS.

12. Students must obey Camp rules and regulations.

We are guests on the campus and must abide by their rules and regulations concerning dorms, dining hall, and all other facilities. Be respectful of camp staff and personnel. Dorm furniture is not to be moved. Any damage to rooms, including removal of ceiling tiles, will be charged to the student's sponsoring church.

STUDENT CAMPER AGREEMENT

By signing this registration form, you are entering into a contract with ETC Youth Camp 2012. Your signature indicates that you know--and your parents and your pastor know--that if you fail to use good judgment and common sense in following the rules above, you will be dismissed from ETC Youth Camp 2012 and returned home at your own or your parent's expense.

Generally, your behavior should reflect these three basic things: 1) Be where you are supposed to be, when you are supposed to be there, doing what you are supposed to be doing, 2) Always pray, always be on time, always be flexible, and 3) Have a good attitude and a teachable spirit.
